The club has 18 holes of championship golf; six asphalt tennis courts with practice wall; a competition size pool; fitness center; clubhouse/locker room facilities; private rooms for meetings; and lounges which serve alcoholic and non-alcoholic beverages.

GENERAL MEMBERSHIP –

\$1,000.00 up front to be credited towards monthly statement at a rate of \$83.33 per month for 12 months and sign a one year contract

NO INITIATION FEE and sign a three year contract**

(Monthly payment includes: \$227.18 dues/Golf Services \$10.55/Assessments \$95.00/Minimums \$43.90)

\$376.63 Monthly Payment

A General Membership consisting of ages 36 and above entitles the member and immediate family to participate in all activities offered by the club; including golf, tennis, swimming, and clubhouse privileges. The member is subject to vote and hold office on the board of directors.

COMPANY GENERAL MEMBERSHIP –

\$1,000.00 up front to be credited towards monthly statement at a rate of \$83.33 per month for 12 months and sign a one year contract

**Or
NO INITIATION FEE and sign a three year contract**

(Monthly payment includes: \$227.18 dues/Golf Services \$10.55/Assessments \$95.00/Minimums \$43.90)

\$376.63 Monthly Payment

A Company General Membership entitles the member and immediate family to participate in all activities offered by the club; including golf, tennis, swimming, and clubhouse privileges. The member is subject to vote and hold office on the board of directors. This membership is retained by the corporation and may be transferred from one company employee to another for a nominal fee. All corporate memberships are classified as General members and only one employee of the company may be designated by the corporation to utilize this membership.

SUCCESSIVE COMPANY GENERAL-

\$500.00 up front to be credited towards monthly statement at a rate of \$41.67 per month for 12 months and sign a one year contract

**Or
NO INITIATION FEE and sign a three year contract**

(Monthly payment includes: \$227.18 dues/Golf Services \$10.55/Assessments \$95.00/Minimums \$43.90)

\$376.63 Monthly Payment

A Successive Company General Membership is only available to Corporations that hold a Company General Membership and said company extends this category to employees within their corporation. This entitles the member and immediate family in all activities offered by the club; including golf, tennis, swimming and all clubhouse privileges. The member is subject to vote and hold office on the board of directors. Initial applicant pays full initiation fee, all monthly fees. Successive members pay ½ of initiation fee and all monthly fees. Owner of the corporation bears the fiduciary responsibility. Should employee leave said corporation, the membership may be released to employee or corporation may replace the employee. If the membership is released to leaving employee, that person will bear the financial responsibility.

JUNIOR MEMBERSHIP-

\$500.00 up front to be credited towards monthly statement at a rate of \$41.67 per month for 12 months and sign a one year contract

**Or
NO INITIATION FEE and sign a three year contract**

(Monthly payment includes: \$146.97 dues/Golf Services \$10.55/Assessments \$40.00/Minimums \$43.90)

\$241.42 Monthly Payment

For those applicants who are between the ages of 21 through 35. When the member reaches their 36th birthday, dues will increase to the General membership level and this membership will then be classified as a General membership. The member is subject to vote and hold office on the board of directors.

SOCIAL MEMBERSHIP - \$750.00+\$73.13 Tax=\$819.38 Initiation Fee

\$ 238.71 Monthly Payment

(Monthly payment include: \$149.81 dues/\$45.00 Assessment/Minimums \$43.90)

A Social Membership entitles the member and immediate family to participate in the following activities offered by the club: Tennis, swimming, and clubhouse privileges. A Social member may also play two rounds of golf per month if accompanied by a General member and must pay the applicable green fees for each round played. The member is subject to vote and hold office on the board of directors.

OUT-OF-TOWN MEMBERSHIP - \$ 410.00+\$39.98 Tax+\$100 Annual Assessment=\$549.98 Annually

Those persons whose permanent residence is located outside a 75 mile radius of Cleveland, Tennessee shall be entitled to become an out-of-town associate for a set fee per year, payable in advance. This fee is not pro-rated according to the time joined. The member shall not be entitled to vote or hold office on the board of directors. NOTE: Out-of-Town members will pay the applicable green fees for each round of golf played.
